## ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution viz. Rahat College of Education, Plot No. 42, Vill/Po-Madhupur, Tehsil/Taluka- Barbad, Town/City-Madhupur, Dist.-Deoghar, Jharkhand – 815353was granted recognition as per Regulations 2009 for conduct of B.Ed. course of One year duration with an annual intake of 100 (one hundred) from the academic session 2013-2014 vide ERC order No.ERC/7-150.6.25/NCTE/B.Ed./2013/16594, dated 02.03.2013.

3. AND WHEREAS, the institution viz. Rahat College of Education, Plot No. 42, VIII/Po-Madhupur, Tehsil/Taluka- Barbad, Town/City-Madhupur, Dist.-Deoghar, Jharkhand – 815353 has by affidavit dated 20.01.2015 consented to come under New Regulations 2014 and sought for two basic units in B.Ed course, which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to fulfill following conditions namely,

- (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committee with required documents by October 31, 2015.
- (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.

(iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition to Rahat College of Education, Plot No. 42, Dist.-Deoghar, Barbad, Town/City-Madhupur, Jharkhand - 815353 for conducting B.Ed Programme of two years duration with an Vill/Po-Madhupur, Tehsil/Talukaannual intake of 100 (one hundred) for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- n) Number of books in the library, journals subscribed to and additions, if any, in
- the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. If it so k) Any faise or incomplete information on website shall render the institution
- liable for withdrawal of recognition.
